ANNOUNCEMENT POWER GENERATION FOR MARCH 2025

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The power generation of China Longyuan Power Group Corporation Limited* (the “**Company**”) for March 2025 on a consolidated basis amounted to 7,567,474 MWh, representing a year-on-year decrease of 2.46% as compared with the corresponding period of 2024, mainly due to the fact that the Company ceased to own coal power consolidated installed capacity from October 2024 and no coal power generation was generated during the month. During the month, the wind power generation registered a year-on-year increase of 7.57%, and PV power generation registered a year-on-year increase of 45.63%.

As of 31 March 2025, the total power generation of the Company for 2025 amounted to 20,286,104 MWh, representing a year-on-year decrease of 4.42% as compared with the corresponding period of 2024; excluding the impact of coal power, representing a year-on-year increase of 8.81%, in particular, the wind power registered an increase of 4.37%, and PV power registered an increase of 55.65%.
